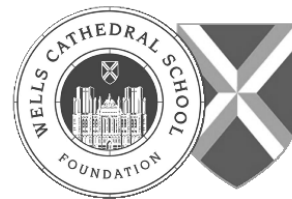

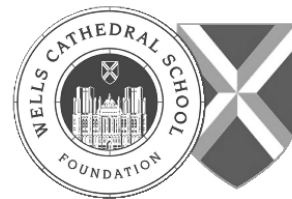

### Direct Debit Guarantee
